

BACHELOR OF DESIGN SUBJECTS

As well as undertaking the 18 core subjects common to the Bachelor of Design, students will undertake the 12 subjects specific to their elective specialisation. Students must successfully complete the **30 subjects - 288 credits** in their chosen Fashion Design, Interior Design or Creative Direction & Styling discipline to enable conferral of the Bachelor of Design award.

SUBJECT FEE

The **Subject Fee Schedule** (Tuition Fee) applies for the current intake of the Bachelor of Design for the domestic students and is subject to annual review and alteration. Any Subject Fee increases are applied at the beginning of each calendar year and will affect the total Tuition Fee*. This does not include additional subject fees due to repeating subjects in the event of unsuccessful completion or reduction of fees due to academic credit awarded. Fees are invoiced on a study period basis based on the enrolled load for that particular study period. All fees are in Australian Dollars and inclusive of GST where GST is applicable. Students are not required to make any Tuition Fee payments when submitting their enrolment documentation. The student can nominate any of the following payment methods to pay Tuition Fees.

- **Defer through FEE-HELP:** Submit completed an electronic *Commonwealth Assistance Form* (eCAF) to defer Tuition Fees to FEE-HELP or
- **Upfront**
 - **In full:** If you elect to pay upfront, Tuition Fees for each study period must be paid in full prior to the commencement of the study period in which you are enrolled.
 - **In part:** Students can elect to pay a portion of their tuition fees upfront and defer the balance under FEE-HELP for each study period of enrolment (provided eCAF is in place).
- Total Tuition fees: \$75,300 (\$12,550 x 6 study periods) *

NOTE: There are 2 intake per year: Trimester 1 in February is the main intake. Students who enrol in the September intake will undertake study period 1 core subjects and then in study period 1 February in the following year will undertake their specialisation subjects.

GENERAL FEE INFORMATION

Students who are accessing FEE-HELP are not required to cancel their eCAF if they subsequently choose to pay their tuition fees upfront in full or in part. If payment is made on or before the Census Date for a subject(s), the student will not incur a FEE-HELP debt for that subject(s).

If a student elects to pay their Tuition Fees upfront, this does not prevent them from accessing FEE-HELP at any time, provided a eCAF is lodged by the end of the relevant Census Date. In these circumstances, a refund of any pre-paid Tuition Fees will apply.

The Late Payment fee will apply for Tuition Fees outstanding after the Administrative Date. In the event that any upfront tuition fees are outstanding after 4 weeks, the appropriate debt recovery actions will be taken. Refer to the Incidental Fees and Charges Schedule.

TERMS OF PAYMENT

- Fees are to be paid in Australian Dollars only
- Payment methods include: personal or bank cheque, Australia Post money order, direct bank deposit, telegraphic transfer, credit card (Visa & MasterCard) or EFTPOS.
- Please note: surcharge for Visa & MasterCard - 0.87%, EFTPOS - 45 cents per transaction will apply
- Cheques are to be made payable to 'Whitehouse Institute of Design, Australia'
- Cash payments exceeding \$150 cannot be accepted.

DEFINITIONS

Administrative Date: The Administrative Date is the last date that you are to complete the requirements for enrolment or progression and finalise tuition fees for the relevant study period. The **Administrative Date** is the **study period commencement date**.

Census Date: is the deadline for various requirements, including submitting your *Request for FEE-HELP Assistance* form for a FEE-HELP loan. If you miss the Census Date, you will not be eligible to access FEE-HELP for that study period and will be required to make up-front payments of your tuition fees. The Census Date is also the deadline for withdrawing from subjects without incurring the full cost of your subject(s) or a FEE-HELP debt. Census Dates occur each study period. It is the student's responsibility to be aware of the Census Dates for each study period of study and notify any changes to their enrolment before this date. It is also the last date that you can change your mind about studying without incurring academic penalty *except in exceptional circumstances*.
