Special consideration

Updated:

A student may apply for special consideration if they consider that illness or misadventure adversely affected their performance in an assessment task, or they were prevented from attendance or submission of a task due to circumstances beyond their control, such as serious illness or hospitalisation.

Database

Special consideration can only be granted due to compassionate or compelling circumstances that are generally those beyond the control of the student and which have an impact upon the student's course progress or wellbeing.

Circumstances which are not considered "special", include:

- public transport and traffic delays
- predictable emotions such as nervousness and stress associated with assessments
- personal celebratory events such as birthdays, weddings, or travel plans
- minor ailments or illnesses where you are still capable of completing assessments
- balancing workloads across subjects of study
- misreading or misunderstanding your timetable, academic plan, or subject outline
- ICT problems, except where they could not have been prevented, avoided or the effects minimised by reasonable diligence on your part.

Extension

An extension may be granted if the student is unable to submit an assessment task by the due date, due to circumstances beyond their control.

Adjustment of assessment mark

An adjustment of assessment mark may be granted if the student submits an assessment task by the due date, but circumstances beyond the student's control has affected the assessment outcome. If granted, the mark will be adjusted to compensate for shortcomings in quality of work.

Reasonable adjustment of assessment mark

A reasonable adjustment of an assessment task may be granted if the student is unable to attempt the given task due to a longor short-term specific disability or special need

Application Process

The following process applies for students who apply for special consideration:

- The application must be made as soon as practical prior to an assessment task due date once the compassionate or compelling circumstances are identified.
- Students must submit a completed 'Application for Special Consideration' form to their Teacher.

Extension

Where the application for special consideration requests an extension, the application is reviewed by the Teacher. The Teacher or senior staff member will advise the student of their decision within 2 working days.

Adjustment of assessment mark

 Where the application for special consideration requests an adjustment of assessment mark, the application is reviewed by a senior staff member, who will advise the student of their decision within 2 working days.

Reasonable adjustment of assessment mark

Where the application for special consideration requests a reasonable adjustment of assessment task, Student Administration will arrange a meeting with the student, a senior and an administration staff member. During this meeting, the parties will negotiate an adjusted Individual Learning Plan.

Supporting documents

- An application for special consideration must by accompanied by a Professional Practitioner Certificate.
- Applications for assessment extensions and or adjustments must be accompanied by a GP - medical certificate, or a Statutory Declaration, or other supporting evidence.
